- Remain in conformance with any decrees, laws, and/or statutes or in an effort to comply with any process which may be served upon ECS and/or our website;
- Maintain, safeguard, and/or preserve all the rights and/or property of ECS; and
- Perform under demanding conditions in an effort to safeguard the personal safety of users of www.ecsflames.org and/or the general public.

Children Under Age of 13
